Brief the case	<p>On 16/17/02.2026 intervening night while SI S Pradhan along with PS staff were performing night patrolling duty in Plantsite PS area after getting reliable information he detected a NDPS case at Bondamunda Road near Phatapipe, Shivsankar Nagar, Rourkela while the accused persons namely Gunanidhi Ghusi, Sukhnanth Oram, Rahul Kumar Sahu, Nikhil Ray, Kaushik Kumar Padhee and Niraj Sonkar were illegally carrying/transporting the 502Kgs. 400 Grams of Contraband Ganja in fiver number of vehicle i.e. (1) One White colour Mahindra Boler Neo vehicle bearing registration NO.OD-23S-7479, (2) One Maruti Suzuki Dezire Car bearing registration No.OD-11C-6491, (3) One Maruti Suzuki Dezire Car bearing registration No.OD-14AZ-3416, (4) One Maruti Sizuki Dezire Car bearing registration No.OD-14-AF-1116, (5) One Silver Colour Maruti Brezza Car bearing registration No-OD.14AG-0019 respectively without any license or authority for selling to general public for their personal gain. The accused persons were procuring the Contraband Ganja from Kandhamal- Boudh side and transporting the same to Jharkhand, Chhatisgarh side for selling purposes.</p>
