Brief the case	Under the ongoing “NASHA MUKTA ODISHA DRIVE”, Plantsite Police conducted a special raid on 23.05.2026 morning at Meenapada, Mahatab Road area under Plantsite Police Station jurisdiction and successfully busted an active Brown Sugar trafficking network operating in the locality. During the raid, 08 accused persons were arrested while they were illegally possessing and selling contraband Heroin (Brown Sugar). The accused persons were allegedly involved in supplying narcotic substances to the general public, including school and college-going students, for unlawful financial gain.
