Case detected	B.Tarang PS Case No. 285 Dt 20.05.2026 U/S 318(4) BNS
Brief of the case	On 20.05.2026 at about 11.55 P.M. complt. Sambhunath Sahu(69) S/o. Late Lal Bahadur Sahu of Village Singhtola, P.S. B.Tarang, Rourkela reported that on 20.05.2026 at about 7 P.M. while he was withdrawing cash from SBI ATM, Singhtola, his ATM Card was stuck inside the ATM machine. By that time one person came to him and asked to contact Help Line No. 7064335852. The complt. contacted the said number from the phone of that unknown person and the receiver asked him about his ATM PIN and the complt. has provided the same. Then the receiver told him to collect his ATM Card on 20.05.2026. On 20.05.2026 when he went to SBI Panposh Branch, he could able to ascertain that an amount of Rs. 2,20,000/- was withdrawn from his account. Hence, on the written report, B.Tarang PS Case No. 285 dt. 20.05.2026 U/S 318(4) BNS was registered and Insp. S. Sendha was entrusted with investigation of this case. During investigation it came to lime light that the accused Guddu Kumar is staying at Ambagaon, Sector 18, Utkal Basti in his uncle's house. He called his brother from his native Gaya, Bihar. Accordingly, his brother along with his another friend came from Gaya and arrived at Rourkela. Then Guddu Kumar told his another friend Sagun @ Asutosh Choudhury, who used to take the brother of Guddu Kumar and his friend in his Scooty No. OD-14-N-1534 to different ATM Counters of Rourkela. They used to put gums/glues with the ATM Machines inside the ATM Card inserter point. They also used to paste papers showing false help-line numbers at different ATM Counters by using sketch/marker pens. Then they all three used to target senior citizens and innocent people who come to ATM for withdrawing cash. Getting opportunities of sticking ATM cards, they used to come forward to help the innocents and thus tactically took the ATM Card and secret PINs. Then they used to withdraw cash by using those ATM Cards and give the same cash to Guddu Kumar. Thereafter, Guddu Kumar deposits the alleged cash in his Account and then transfers the amount to the account of his sister-in-law. Another accused Subham Nayak harboured the accused Sagun @ Asutosh Choudhury after the occurrence in his Prestige Hotel in order to evade any Police action against him.
