Brief of the case	As part of the on-going special enforcement and anti-illegal mining drive, Rourkela Police achieved a significant success during night blocking and Naka checking conducted on the intervening night of 04/05.06.2026 under the supervision of SDPO, Panposh and as per the directions of the Superintendent of Police, Rourkela. At about 03:30 AM, a Hywa truck bearing Registration No. OD-15-6425 carrying sand was noticed moving at high speed from Kuarmunda towards Rourkela. Despite being signalled to stop, the driver attempted to evade police checking and fled from the spot. The police team immediately pursued the vehicle and successfully intercepted it near Sankh Bridge on the Kuarmunda side. During subsequent verification, the vehicle was found transporting sand without valid Transit Pass (TP) or supporting documents. Further checking led to the detention of two more vehicles, i.e., one Hywa (Regd. No. OD-14-AB-7211) and one Dumper (Regd. No. OR-09-K-5308), both loaded with sand and found operating without valid transportation documents. Preliminary enquiry revealed that the sand had been loaded from Pradhanpali Sand Quarry and was being transported to different destinations including TCI, IDC, and Koida. The involvement of the quarry lessee and vehicle operators in illegal transportation and sale of sand is under investigation. All three vehicles have been detained and necessary legal action has been initiated as per law. Further enquiry is in progress to ascertain the full extent of the illegal mining and transportation network.
