Brief the case	On 16.06.2026, following a previous dispute, a group of accused persons allegedly attacked Tophan Bindhani of Rameswar Palli, Sector-06, PS-Sector-07 and his associates near Sector-06, Rourkela with deadly weapons, resulting in the death of Tophan Bindhani and grievous injuries to another person. During the investigation of the above case, reliable information was received regarding the movement of the accused persons near the Jhirpani area. Acting on the information, a police team launched a search operation during the early hours of 20.06.2026. During the operation, the accused persons allegedly opened fire at the police party, resulting in an exchange of fire. Two accused persons sustained injuries and were shifted to RGH, Rourkela for treatment, while three other accused persons were apprehended. Further investigation is in progress, and efforts are underway to apprehend the remaining accused persons.
